Family Support and Health Care Program - During FY 2009 this program made a significant difference in the lives of low-income clients. 410 Medicaid and 364 Social Security cases were handled for clients. The program obtained or preserved Medicaid benefits for 110 clients and obtained or preserved Social Security, SSI, Work First Family or Food Stamp benefits for 79 clients for a total value of \$5.7 million in benefits. The program also filed a class action case, challenging the lack of due process protection for Medicaid recipients when services are denied, reduced or terminated.

Immigrant Justice Program - During FY 2009 this program made a significant difference in the lives of low-income clients. The program obtained or enforced 112 domestic violence protective orders, child custody and child support orders. The program also obtained legal immigration status for 34 clients and prepared immigration paperwork for 112 others.

Consumer Protection - During FY 2009 this program made a significant difference in the lives of low-income clients. The project successfully offered advice and resolved consumer disputes for 695 clients, obtained bankruptcy protection for 7 clients and eviction or foreclosure was prevented or delayed in 15 cases. The program reduced \$1 million worth of debt for clients.

LSSP accomplishes its mission through a variety of legal advocacy strategies including direct individual advice and representation, community education and outreach, representation of groups, self-help remedies, collaboration with other agencies, community economic development, legislative and administrative advocacy, and impact litigation.

The three additional programs of LSSP:

The Western North Carolina Low Income Taxpayer Clinic provides legal assistance in tax matters to eligible low-income workers and families.

The Employment Law Project ensures that working people facing layoffs from their jobs have full access to the unemployment insurance benefits for which they are eligible. Unemployed workers who do not receive unemployment insurance benefits quickly exhaust their savings as they find and/or retrain for new work.

The Legal Services for the Elderly Project provides legal services for transitional planning including wills, financial and health care powers of attorney and other advance directives, and guardianship as well as family and consumer law.
